

Board of Directors of DC Green Bank Meeting Minutes of Board Meeting #2021.02.12.RBO Friday, February 12, 2021 2:04pm - 2:57pm

A meeting of the Board of Directors of DC Green Bank was held on **Friday, February 12, 2021** via teleconference.

1. Call to order and verification of quorum

DC Green Bank Board Chair, Brandi Colander, called the meeting to order at 12:04pm. Ms. Colander asked Mr. Ed Hubbard to verify a quorum. With five (5) voting members present, the Board had a quorum and the meeting continued.

2. Adopt the Agenda and Approval of the Minutes from Board Meeting #2020.12.22.RBO A motion was made to adopt the February 12, 2021 meeting agenda and to approve the minutes from the December 22, 2020 Board meeting by Mr. Nogueira. The motion was seconded by Mr. Hubbard. After a roll call vote, the motion passed (5-0-0).
