

# Board of Directors of DC Green Bank Meeting Minutes of Board Meeting #2021.03.18.RBO Thursday, March 18, 2021 12:03pm – 12:25pm

A meeting of the Board of Directors of DC Green Bank was held on **Thursday, March 18, 2021** via teleconference.

#### 1. Call to order and verification of quorum

DC Green Bank Board Chair, Brandi Colander, called the meeting to order at 12:03pm. Ms. Colander asked Mr. Ed Hubbard to verify a quorum. With five (5) voting members present, the Board had a quorum and the meeting continued.

2. Approval of the Minutes from Board Meetings #2021.02.12.RBO and #2021.03.03SBO Motions were made to approve the minutes from the February 12, 2021 Regular Board and March 3, 2021, Special Board meetings by Mr. Nogueira. The motions were seconded by Ms. Jayachandran. After roll call votes, both motions passed (5-0-0).

#### 3. Public comments

DC Green Bank received one (1) request for comments from the public, but the requestor did not attend the meeting. As a result, no public comments were made.
