

Board of Directors of DC Green Bank Meeting Minutes of Board Meeting #2021.04.15.RBO Thursday, April 15, 2021 12:07pm – 12:26pm

A meeting of the Board of Directors of DC Green Bank was held on **Thursday, April 15, 2021** via teleconference.

1. Call to order and verification of quorum
