

Board of Directors of DC Green Bank Meeting Minutes of Board Meeting #2021.08.04.RBO Wednesday, August 4, 2021 12:02pm – 12:21pm

A meeting of the Board of Directors of DC Green Bank was held on **Wednesday, August 4, 2021** via teleconference.
