

Evergreen Energy

DC Green Bank closed on \$2.65 million in financing, alongside \$2.65 million from City First Enterprises, for the installation of solar energy systems at 335 homes in DC. The solar arrays will save these households an average of 90% on their utility bills. Threequarters of the households receiving the systems will be low and middle income and at least 175 of the households will receive the energy generated by the solar systems at zero cost.

Projected Project Impacts:

- 335 households with solar power, 75% LMI
- 3.685 MWh annual energy generation
- 90% average energy savings
- Wards Impacted: Multiple


